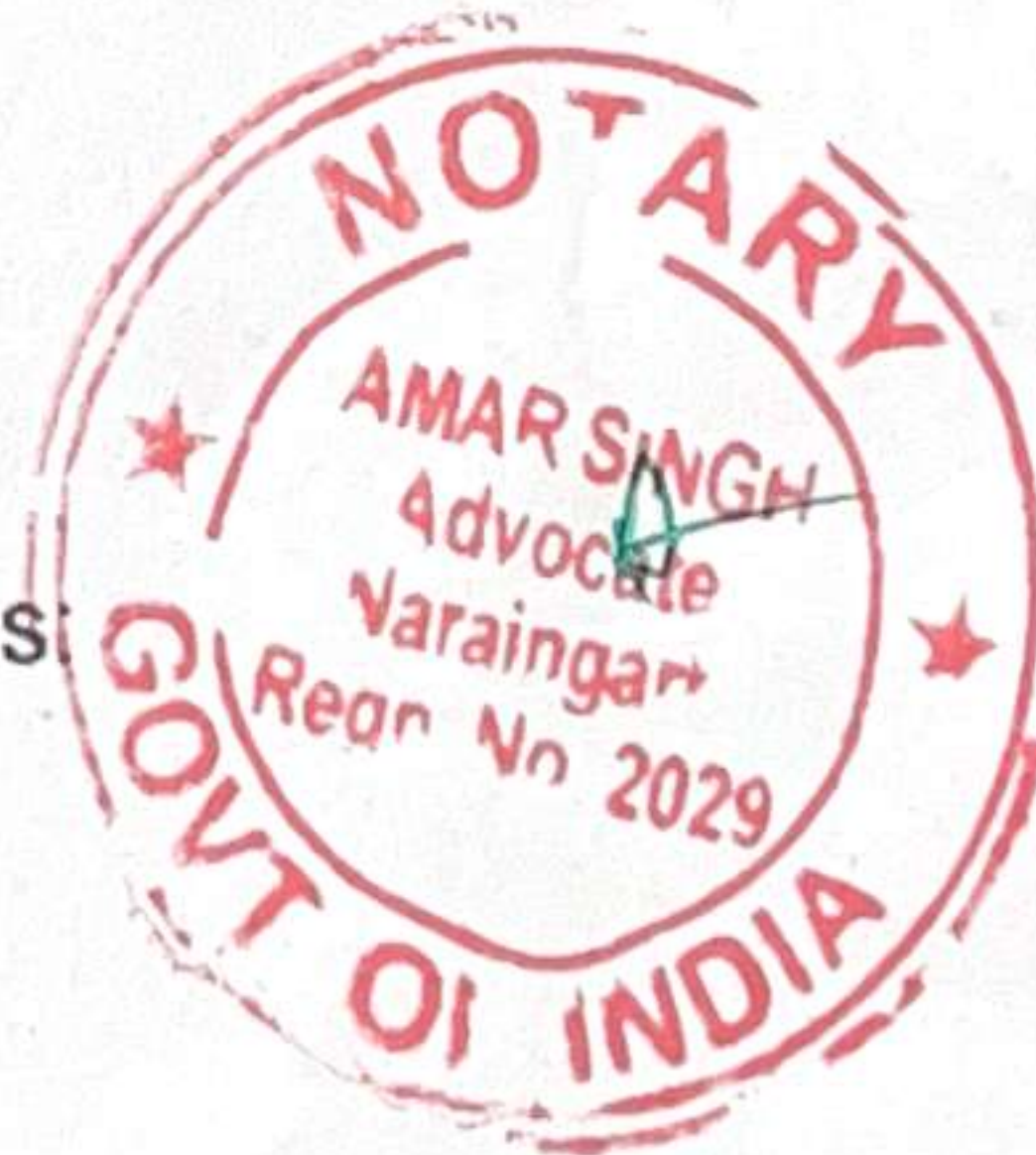

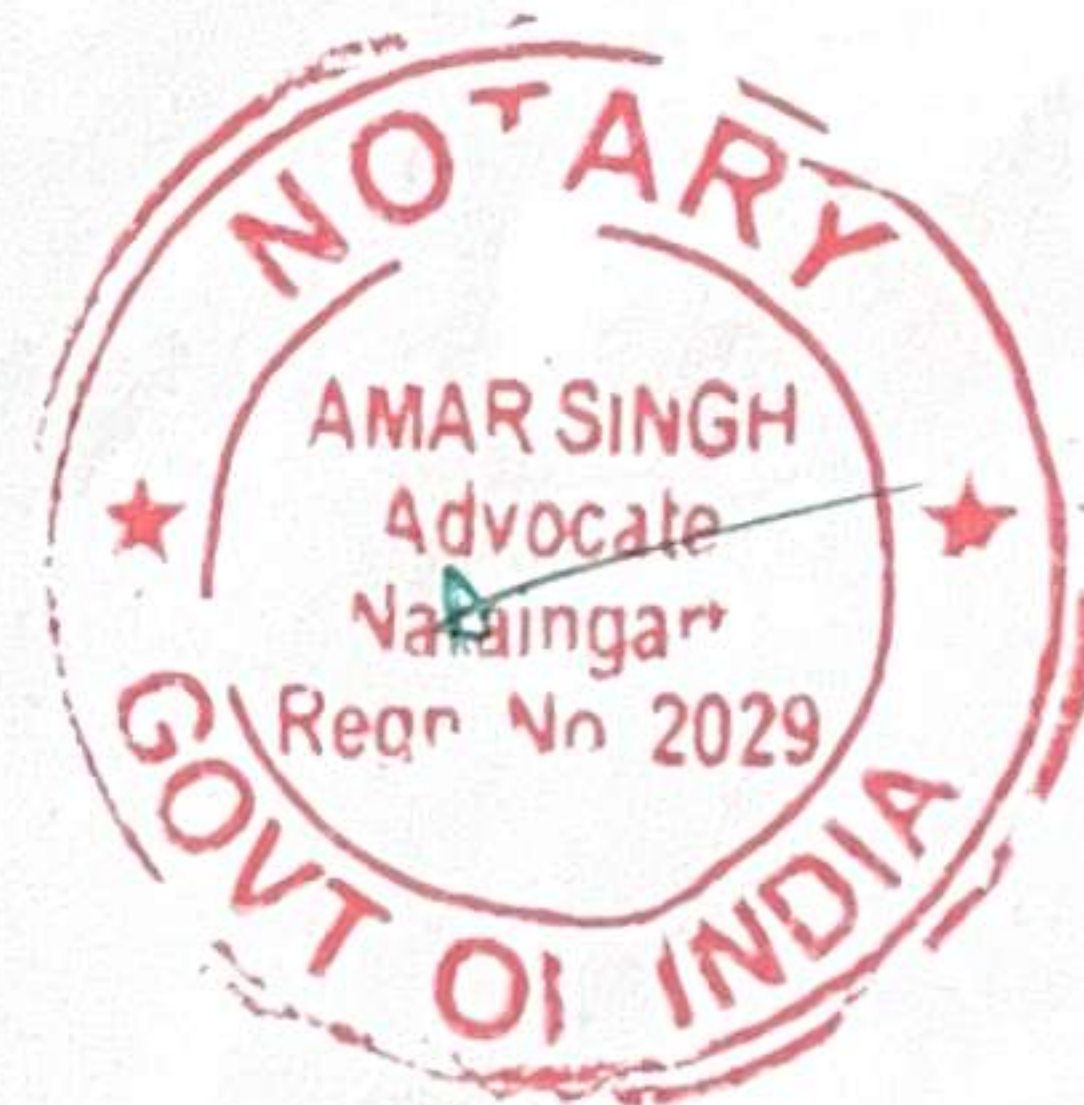

Alar Solutions shall:

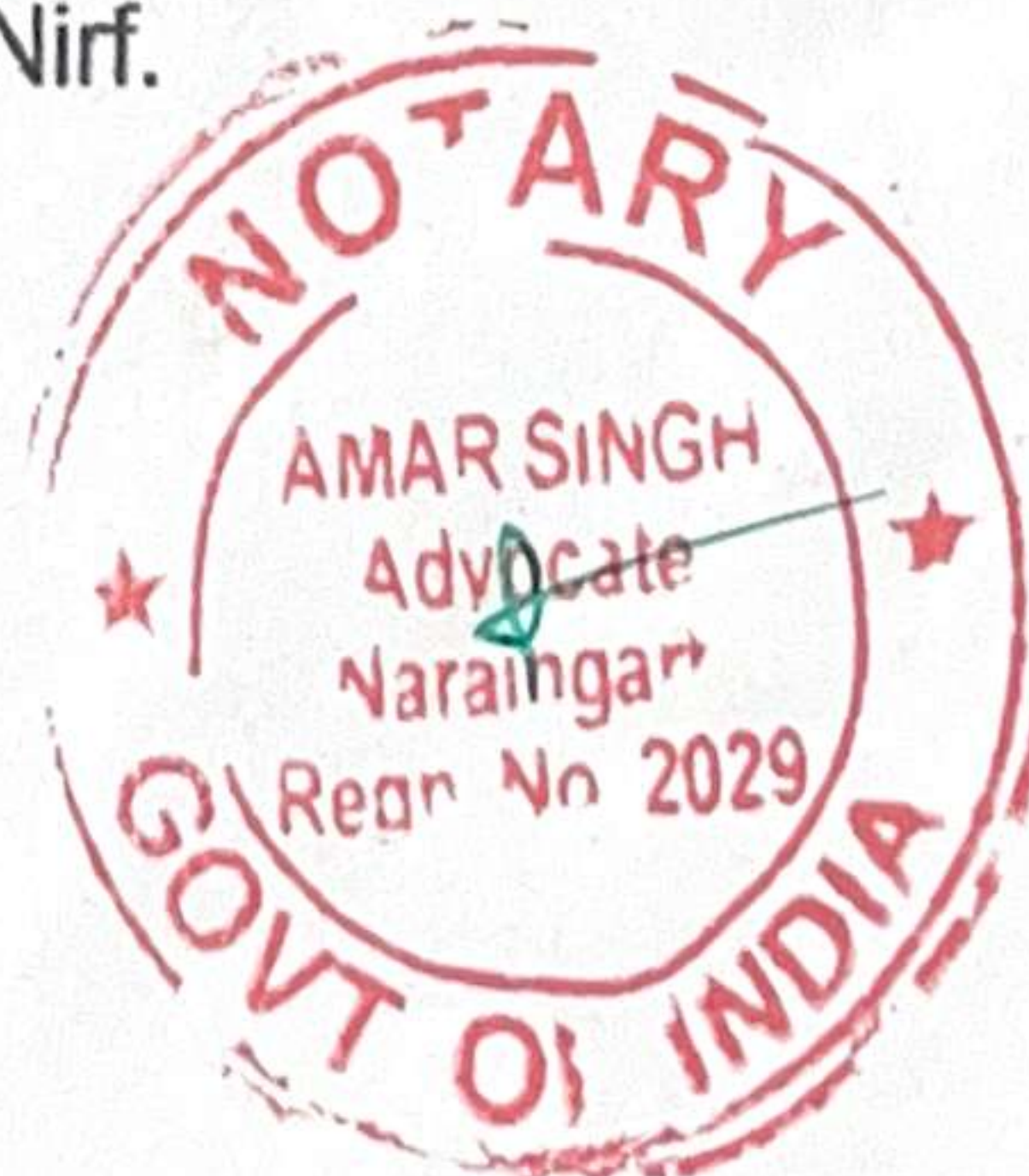
1. Design and establish the TalkMyCareer Club.

Club President — Nominated by Faculty Mentor and selected by Alar Solutions on the basis of Interview and academic performance.

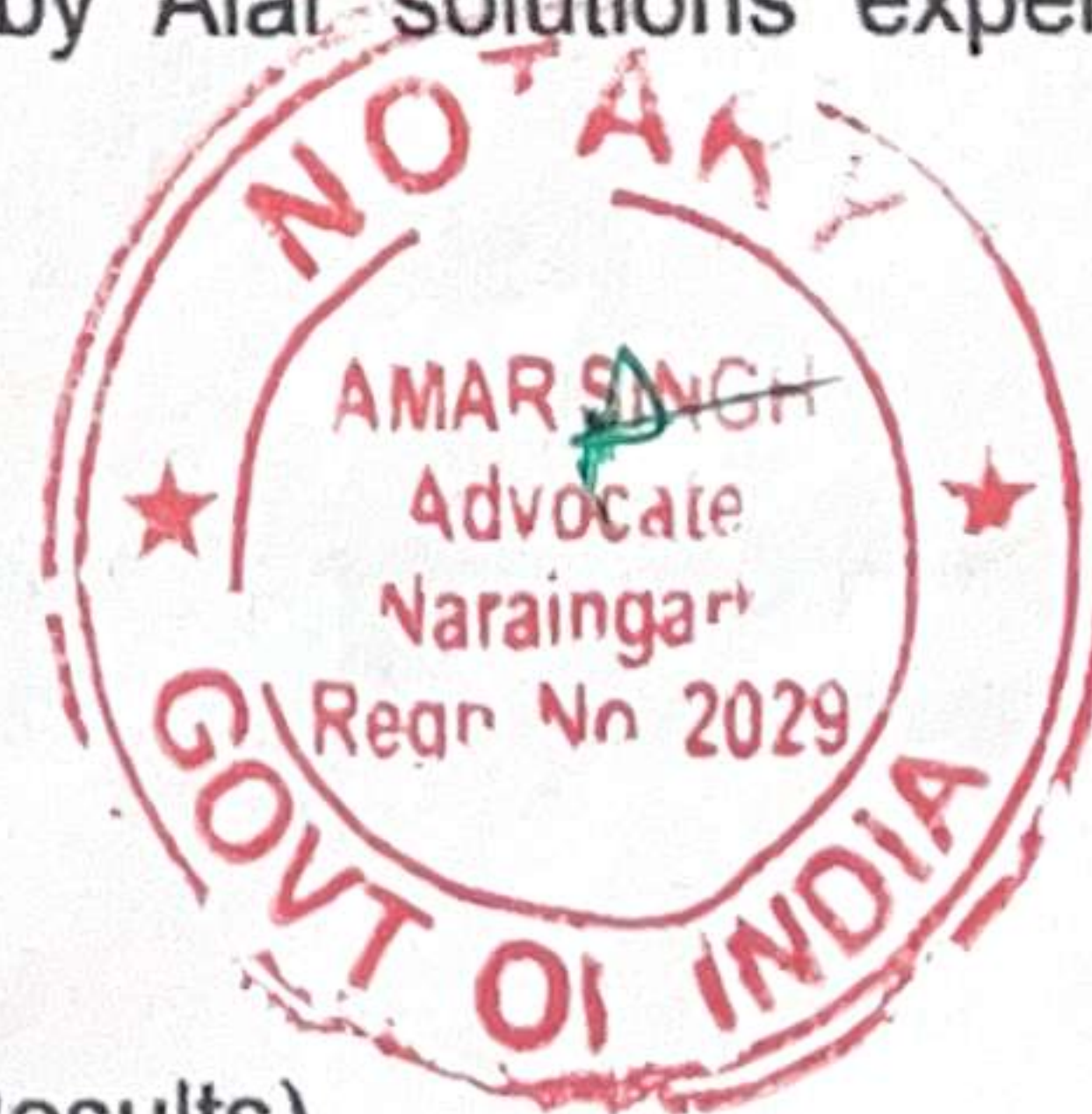

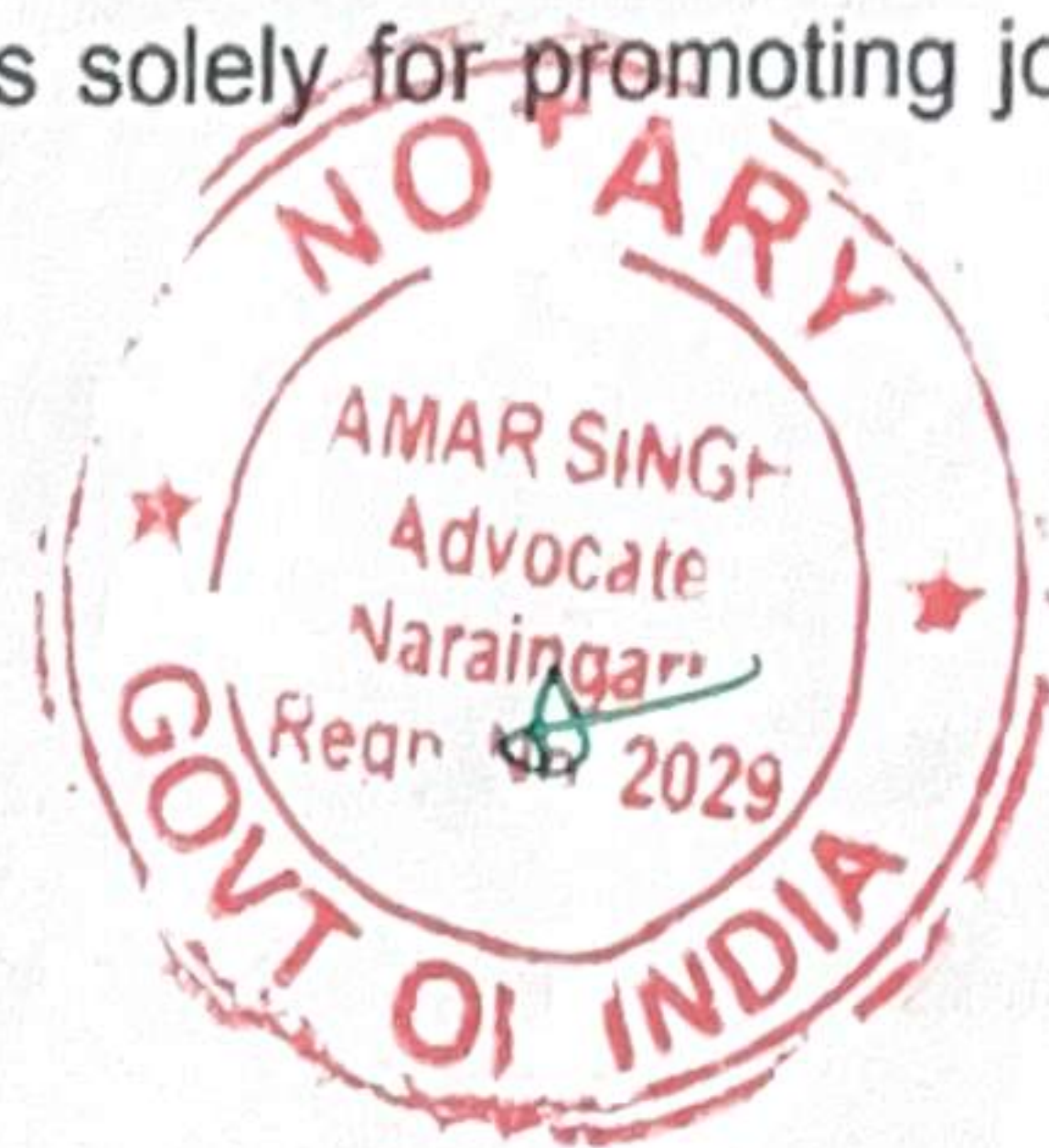


- Placement or internship offers shall remain subject to employer eligibility criteria, interview performance, academic requirements, and business needs.

8. Branding

9. Financial Arrangement

Unless agreed separately in writing:

The establishment of the TalkMyCareer Club shall be on a collaborative basis. There is no financial/commercials involved between TalkMyCareer and the Institution or student.

However, Student body themselves will organise events to generate revenue and get sponsorships to self-sustain the club, for which the books will be maintained by the Club Vice President- Finance

10. Confidentiality

Both parties agree to maintain confidentiality of all proprietary, institutional, business, and student-related information shared during this collaboration and shall comply with applicable data protection laws.

11. Intellectual Property

Training materials, software, assessments, digital platforms, methodologies, and content developed by Alar Solutions shall remain its intellectual property unless otherwise agreed in writing.

13. Duration

This MoU shall remain valid for three (3) years from the Effective Date unless terminated earlier by either party.

It may be renewed by mutual written consent. ---

Either party may terminate this MoU by providing 60 days' written notice. Activities already initiated shall, where practical, be completed amicably. ---

15. Dispute Resolution

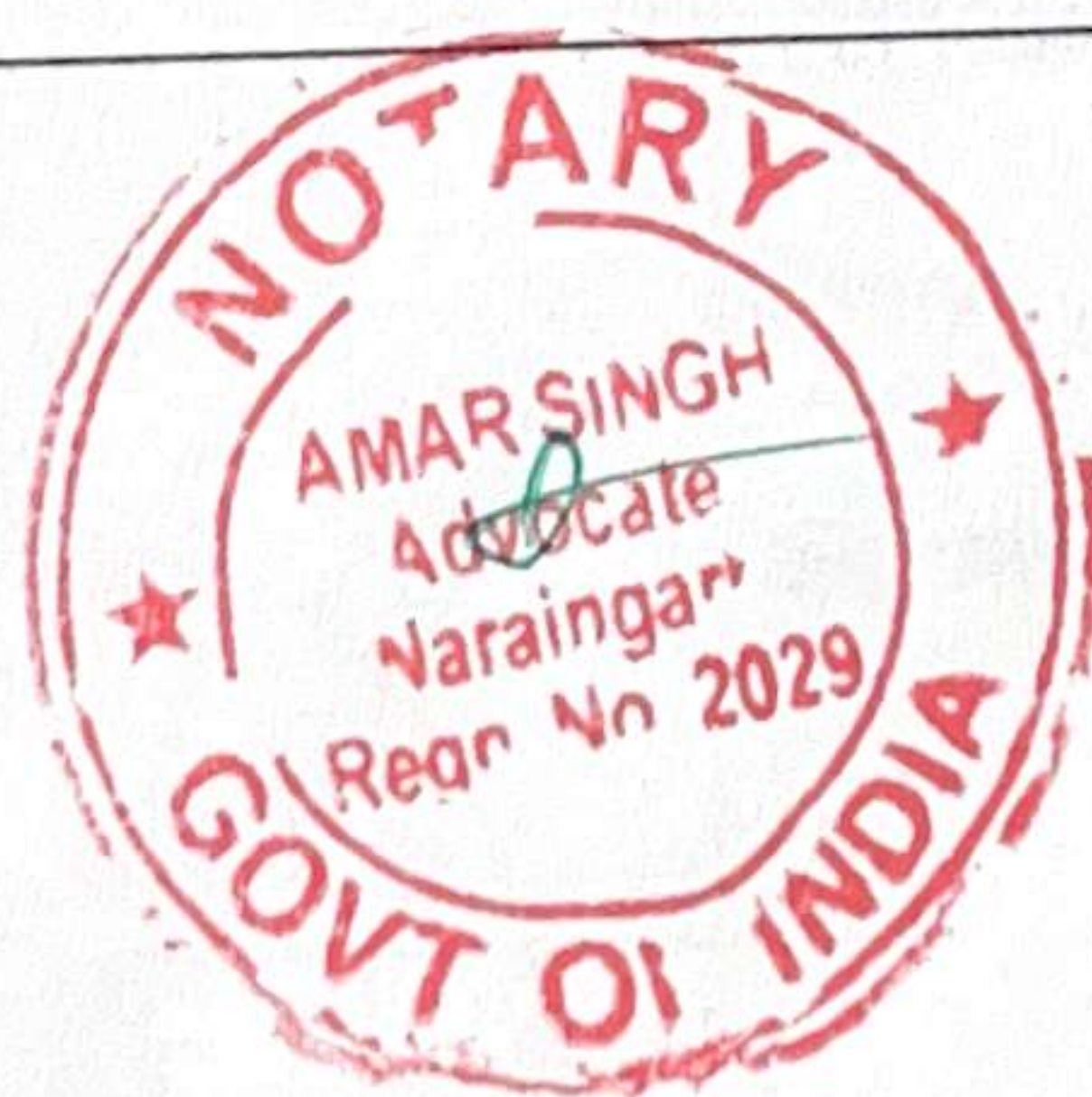
Any dispute arising out of this MoU shall first be resolved through mutual discussions.

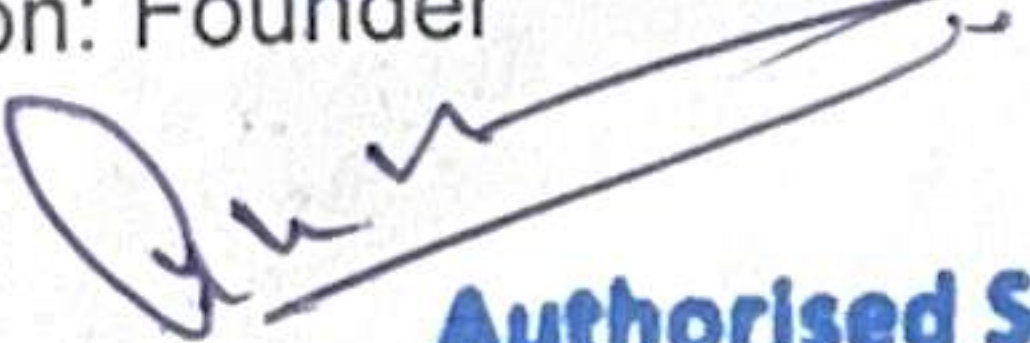
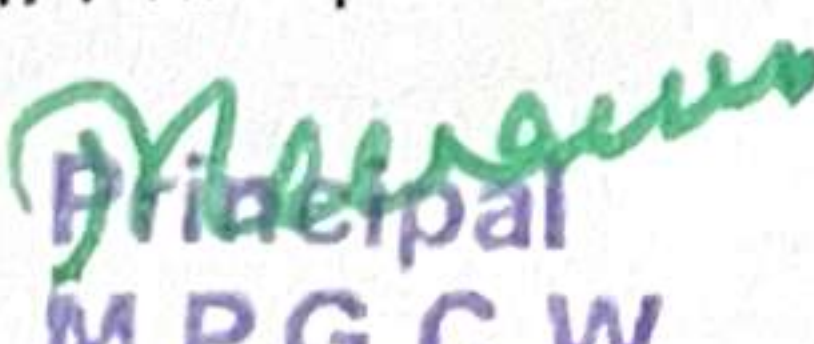
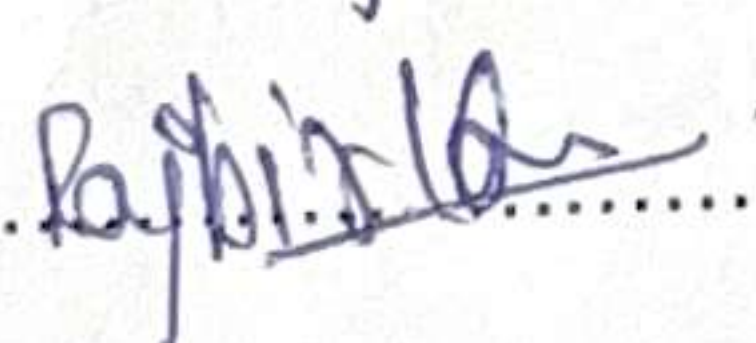
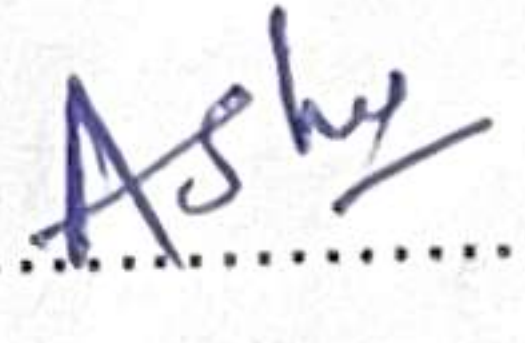


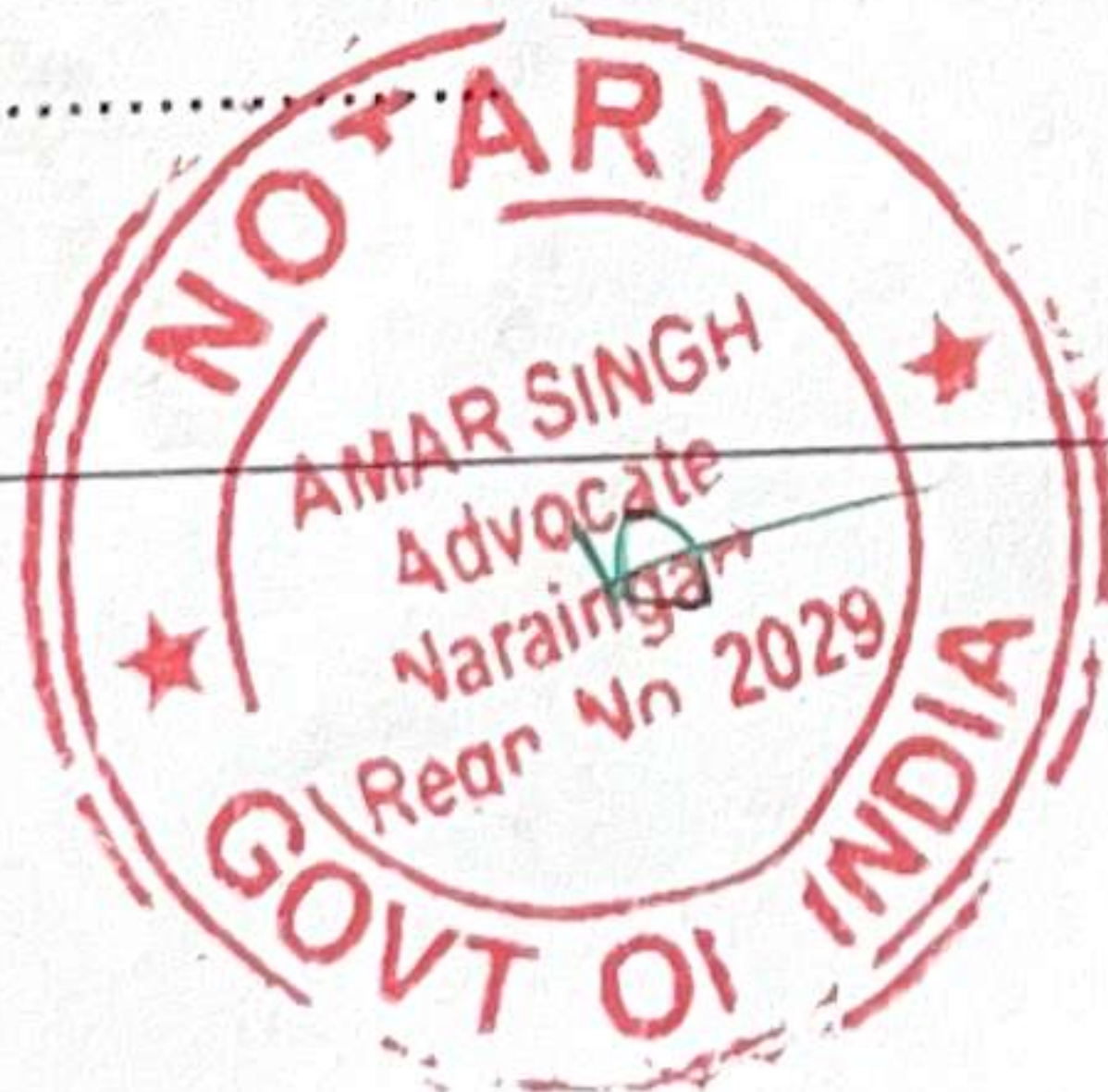


17. General Provisions
